INVITATION FOR SUBMISSION OF PROPOSALS FOR PROJECTS TO BE IMPLEMENTED WITHIN MOQHAKA MUNICIPALITY: REF NO: 001/2018-19

- 1. The Moqhaka Municipality has infrastructure projects which are unfunded that must be implemented in Kroonstad, Viljoenskroon and Steynsrus.
- Written Proposals are invited from suitably qualified Firms/ Companies, Consortium or JV
 Professionals to be appointed on Risk Appointments within Moqhaka Municipality for the period
 of Three Years.
- 3. The on-risk appointment entails the following:
 - Analysis of water infrastructure, waste water infrastructure, storm water infrastructure, roads infrastructure, electricity infrastructure, landfill sites, sport facilities, and any other projects that will be identified at a later stage within Moqhaka Municipality,
 - Compilation of business plans and sourcing of funding,
 - Project administration, implementation and total project management and supervision.
- 4. It should however be noted that the appointment of suitable service providers is subject to the **CONDITION** of funding approval with regards to funding applications to be prepared and submitted by yourselves.
- 5. The following information should also be included with your proposal:
 - the company registration details;
 - tax clearance certificate
 - proof of CSD Registration
 - vision and mission;
 - professional credibility;
 - core expertise;
 - major projects undertaken;
 - Office structure and core staff;
 - references: and
 - contact details.

N.B.: Preferential treatment in this regard will be given to Companies / Firms who can secure finance with one or more financial institutions within the shortest space of time.

6. The bids will be evaluated in accordance with the functional evaluation criteria as set out under Annexure A below:

Technical or Functional Evaluation Criteria and Functional Evaluation Report Guideline

Only those tenderers who score the maximum of 60 points in respect of the following criteria are eligible for further evaluation.
